## QUALIFIED VOTERS

To qualify as a voter you must be a resident or own property in the municipality for at least 6 months before Election Day (April 27, 2010).

#### RESIDENT VOTERS....

A Canadian Citizen

At Least 18 years of age on Election Day

A resident of the local authority for 6 months prior to Election Day

#### NON RESIDENT VOTERS.....

A Canadian Citizen

At least 18 years of age on Election Day

A maximum of two non-resident voters per property are permitted to vote in a municipal election. If more than two non-residents own a parcel of land, each property owner must obtain written consent from the majority of the other registered landowners and file an application with the SEO to have their names included on the voters list.

#### QUALIFICATION OF CANDIDATES (who can run)

A Canadian Citizen

At least 18 years of age on Election Day

A resident of Manitoba

A voter in the municipality in which you seek office.
